**ADVISORY NOTE  
VIDEO SURVEILLANCE  
EX ART. 13 UE REG. 2016/679**

We hereby inform the public and third parties that our company, due to corporate assets and occupational safety protection, has installed cameras at entrances and exits of its plants in Esine, Via Ruc, 30.

The Data Controller is TRAFILIX S.p.A Via Ruc, 30 - 25040 Esine (BS)- Italy, in the person of the legal representative *pro tempore* contactable at Tel. +39 0364 36 76 11 - Fax +39 0364 46 67 13 – mail: [info@trafilix.com](mailto:info@trafilix.com) .

Plants are in operation 24h a day.

Data will be processed in accordance with the principles of human rights, fundamental freedoms and dignity of people, with particular reference to confidentiality, identity and protection of personal data.

Data will be processed through IT procedures and are viewed only by the Data Controller, the persons in charge and the maintenance personnel.

The collected data will be **kept** only for **24h** and then automatically deleted and they won't be released, sold or transferred to third parties, except in case of crimes against our company; in this case, they will be made available to competent authorities.

Near the plants, specific banners have been installed, which contains legal minimum information, referring back to this note.

The **purposes** of the processing are corporate assets and occupational safety protection.

The **legal basis** for processing personal data is linked to the data controller's legitimate interest to protect corporate assets and occupational safety (and therefore, is also linked to the workers' legitimate interest).

According to the provisions of UE Regulation 2016/679, you, being the data subject, have the right:

- to obtain confirmation, or otherwise, of the existence of personal data that concerns you, even if not yet recorded, and the communication, in an intelligible form, of the same data and its origin, including the purposes for and the means of processing and the logic applied in the case that the processing is carried out by electronic instruments;
- to obtain the deletion, transformation into anonymous form or the block of the personal data for which conservation is not necessary in terms of the reasons for which the data was collected and processed;
- to obtain the updating, correction and integration of your personal data;
- to oppose, in whole or in part, for legitimate reasons, the processing of the personal data that concerns you, even if pertinent to the reason for which the data was collected;
- to request and to obtain from the Data Controller – in the cases in which the legal basis for processing is either contractual or consensual and is done by automated means – a copy of your personal data in a structured format that can be read by an automated device, including for the purposes of sending this data to another data controller (the so-called right for the personal data to be portable);
- to revoke at any time any consent you may have previously given, limited to the cases in which processing is based on your consent for one or more specific purposes and concerning common personal data (for example, date and place of birth or place of residence), or particular categories of data (for example, data that concerns your racial ethnicity, your political views, your religious convictions, your state of health and your sexual preferences). Processing based on consent and performed up to the point at which you revoke your consent, remains, however, legitimate;
- to lodge a complaint with the Supervisory Authority (which, in Italy, is the Italian Data Protection Authority [Autorità Garante per la protezione dei dati personali – [www.garanteprivacy.it](http://www.garanteprivacy.it)]).
